Expression of Interest/offers under sealed cover are invited by the undesignated in plain paper from the bonafide and certified seller of paddy & non-paddy seeds (Pulses, Oil seed, Potato, Finger Millets, Vegetable seeds etc.

The date of receiving of offers/ Expression of Interest starts from 20.08.2020 & will be continued up to 2.00 PM on 18.09. 2020. The outcome of the offers obtained will subsequently be informed in due course. The offer in sealed cover will be received during the period in any office working hours between 11.00 AM to 3.00 PM. Only hard copy in sealed cover is to be submitted. Soft copy will not be accepted in any circumstances.

**1.2.-** The above varieties wise quantities of Certified and Truthful label seeds produced or to be produced by WBCADC Projects approximately which scenario may be changed according to the market demand. All the Bonafied, experienced, reputed and successful Distributors/ Dealers whose are to be placed their firm indent considering the above, subject to advance **Rs 30000/-** as security deposit. Cost of seeds to be fixed by WBCADC well ahead. The distributors/dealers may place their variety wise quantity's demand with advance at least two months before the season started.

The cost of seed is fixed by WBCADC which is to be informed to the distributors and dealers concerned well ahead. The advance will be adjusted with last two supplies by the distributors/dealer.

**1.3-** The intending distributors/dealers may discuss about clause no-1.2 to WBCADC for finalizing the matter well in advance on the need base for such discussion, WBCADC may call a meeting on the issues.

**1.4-** Commission per MT may suppose to allow subject to quantities of seeds to be procured by the distributors/dealers which as follows:-

i)- in case of paddy (all season)

**06% on 35 MT& above**

**08% on 65 MT& above**

**10% on 100 MT & above**

Apart from the above, there is no other facilities may be allowed for the purposes.

In case the distributors/dealers failed to procure minimum quantity of **35 MT**, the distributorship or dealership will not be renewed in any case.

**1.5-** the payment is cash on delivery system. The Corporation will not bear any responsibility for seeds after receipt by distributors/dealers.

**1.6-** The payment on entire stock of different stages of seed against firm indent is to be made by the successful distributors/dealers by phase and **10%** advance may have to be deposited for the next phase procurement and after completion of last phase procurement of indented stock may be adjusted accordingly by the concerned Project/Projects.

**1.7-** Indent on variety wise quantity to be placed by the successful distributors/dealers with advance or security deposited there is no modification will be allowed on the given firm indent if once is placed. After delivery of seed as per indent of distributors/ dealers must check the quantity & quantities and no return will be made after receiving the stock of seed when the stock is lifted by the distributors /dealers from WBCADC Projects.

**1.8-**Incentive may be allowed to the distributor/dealer who have performed better as per authority's decision

**1.9-** The Distributors/dealers may inform their opinion before execution of **MOU** or agreement to WBCADC, if found any gap on earlier discussion which has not been entertained

**1.10.-** The distributors/dealers will have the access to change the variety/varieties wise quantities in case of all kind of seed to be produced by the WBCADC.

**1.11-** If distributors/dealers are unable to procure the quantities of seeds as mentioned in the **clause 1.4**, they would be allowed the cost of seeds as retail price fixed by the WBCADC.

**1.12-** In case of Pulses/Oil seed/Finger Millets/Potato/Wheat etc, the commission may be allowed on the procured quantity of seeds is not at per Paddy seeds, causing the requirement those seeds than paddy seed is less as the coverage in the state level is less, not like paddy. So, the commission may be fixed as follows on the procure quantity of the following seeds.

<b>i) Pulses and Oil seeds</b>	<b>05% on 05MT&amp; above</b>
<b>ii) Potato</b>	<b>08% on 10MT&amp; above</b>
<b>iii) Finger Millets</b>	<b>06% on 10MT&amp; above</b>
<b>vi) Wheat</b>	<b>05% on 05MT&amp; above</b>
<b>v) Vegetable (But rate of seed cannot assessed)</b>	<b>10 % on 0.050MT&amp; above</b>

**1.13-** The Tenders document will be submitted by the distributors/dealers as follows:-

- Trade licence
- Seed licence in form-B or C may be (clause 5,6 of the seed amendment order 1983)
- PAN, GST Reg. with last return.
- Certificate of incorporation/Partnership Deed/MOA/AOA/Registration certificate.
- Three( 03) years Credential along with completion Certificate(supply Order of Govt. organisation or Autonomous Body)
- Income Tax Return (Last 03 years)
- Receipt copy of last monthly return in form-D (clause-18).

**1.14-** The distributors/dealers will have to inform the choice of variety/varieties along with quantity of any kind of seed to WBCADC before five month ahead of the season started.

**1.15-** Renewal period may be framed up for one year by depositing **Rs 2,000/-** (Rs five thousand) only as renewal fees (non refundable) for the successful distributors/dealers through Demand Draft on SBI or UBI payable at Kolkata in favour of WBCADC Head of account.

**1.16-** Indented seed materials to be procured from go-down of the WBCADC District Projects by the successful distributors/dealers after checking the seed stock with prior intimation to the Project Authority.

**1.17-** The tender for the purposes of above may be valid for three years subject to every year renewal must be done by the successful distributors/dealers, if the Authority permits, then the distributors/dealers may have an opportunity to select the varieties and quantities of any kind of seeds.

**1.18-** Distributors/dealers may be mentioned the zone/area of marketing of WBCADC seeds.

**1.19-**Rate of any kind of seed is to be fixed as per discretion of the Authority, which is binding to the concerned agency.
